<u>Commission</u> - Used throughout this tariff to mean the Missouri Public Service Commission.

Company or Global Crest - Used throughout this tariff to mean Global Crest Communications, Inc., a Florida Corporation.

<u>Customer</u> - The person, firm, corporation or other legal entity which orders the services of the Company or purchases a Company Prepaid Calling Card and/or originates prepaid calls using such cards, and is responsible for the payment of charges and for compliance with the Company's tariff regulations.

#### 3.1 Computation of Charges

- 3.1.1 The total charge for each completed call mission be a variable measured charge dependent on the duration, distance and time of day of the call. The total charge for each completed call may also be dependent only on the duration of the call, i.e. a statewide flat rate per minute charge. The variable measured charge is specified as a rate per minute which is applied to each minute. All calls are measured in increments as set forth in the Rates Section of this tariff. All calls are rounded up to the next whole increment.
