ORDER CANCELING CERTIFICATE AND CANCELING TARIFF

This order cancels the certificate of service authority to provide intrastate interexchange telecommunications services granted to GE Business Productivity Solutions, Inc., along with its accompanying tariff.

The Commission granted GEBPS a certificate of service authority to provide intrastate interexchange telecommunications services in Case No. TM-2001-578.¹ The Commission also approved GEBPS's tariff, P.S.C. MO No. 2, in that same case.

On December 14, 2004, the Commission issued an order approving the transfer of assets from GEBPS to Business Productivity Solutions, Inc. As part of that order the Commission stated that when the transactions were completed, GEBPS's certificate and accompanying tariff would be canceled as requested by GEBPS.

¹ GEBPS was formerly known as GE Capital Telemanagement Services Corporation.

GEBPS filed a Status Report on April 14, 2005, stating that the transactions had been completed and that this case was ready to be closed. In response, the Staff of the Missouri Public Service Commission filed a motion to cancel GEBPS's certificate of service authority and the accompanying tariff.

The Commission finds that since the company is no longer operating in the state, it would be in the public interest to cancel the certificate and tariff of the company. Therefore, the certificate of service authority granted to GEBPS in Case No. TM-2001-578, along with its accompanying tariff, will be canceled.

IT IS THEREFORE ORDERED:

1. That the certificate of service authority granted in Case No. TM-2001-578 to GE Business Productivity Solutions, Inc. (formerly known as GE Telemanagement Services Corporation), along with its accompanying tariff, P.S.C. MO No. 2, is canceled.
2. That this order will become effective on May 1, 2005.
3. That this case may be closed on May 2, 2005.
