ORDER APPROVING TARIFFS IN COMPLIANCE
WITH COMMISSION ORDER

On December 29, 2005, in Case No. LA-2005-0155, the Commission granted Pac-West Telecomm, Inc., a certificate of service authority to provide interexchange, non-switched local exchange and basic local telecommunications services. In that order, the Commission ordered Pac-West to file tariffs in a separate case before offering basic local exchange services.

On January 27, 2006, Pac-West filed P.S.C. Mo. Tariff No. 1 (Tariff No. YL-2006-0580) and P.S.C. Mo. Tariff No. 2 (Tariff No. YL-2006-0581), each bearing an effective date of March 15. Pac-West filed substitute tariff sheets for both tariffs on February 3. In addition, Pac-West filed substitute tariff sheets for Tariff No. YL-2006-0581 on February 14, 16, 21, and March 1.

On March 2, the Staff of the Commission filed its Recommendation. Staff recommended that the Commission approve the tariffs.

The Commission has reviewed the tariff filings and the Staff Recommendation. The Commission determines that the tariff sheets comply with the applicable statutes. The Commission will approve the tariffs.
