ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: May 17, 2016

Effective Date: May 27, 2016

On April 18, 2016, Global Telecom & Technology Americas, Inc. ("Global Telecom") filed notification for the discontinuance of services and requested the Commission cancel their certificate of service authority and accompanying tariff to provide telecommunications services in the State of Missouri.

In File Number XA-2002-1042¹, the Commission granted Global Internetworking, Inc. a certificate of service authority to provide telecommunications services in the State of Missouri, and approved its tariff. On March 14, 2007, the Commission recognized a name change to Global Telecom & Technology Americas, Inc. Specifically Global Telecom was approved to provide interexchange telecommunications services. The Company's tariff, P.S.C. MO No. 1 was also approved.

¹ In the Commission's April 20, 2016 *Order Directing Staff to File a Recommendation*, the Order incorrectly notes the certificate granting telecommunications services occurred in Case No. XA-2007-0561, which was incorrectly stated in the Company's request for cancellation. Staff's May 2, 2016 *Recommendation* included the correct case number, as listed above.

On April 20, 2016, the Commission issued an Order Directing Staff to File a Recommendation. On May 2, 2016, Staff filed their recommendation and stated that Global Telecom is discontinuing wireline telecommunications services in the State of Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide telecommunications services and the company's accompanying tariff.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Global Telecom's request and Staff's recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to Global Telecom & Technology Americas, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Global Telecom & Technology Americas, Inc., in File Number XA-2002-1042, is canceled.
2. Global Telecom & Technology Americas, Inc.'s tariff, P.S.C. MO No. 1 is canceled.
3. This order shall become effective on May 27, 2016.

4. This case may be closed on May 28, 2016.
