ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFFS

Issue Date: October 26, 2016

Effective Date: November 5, 2016

On September 16, 2016, TNCI Operating Company, LLC ("TNCI") filed notification for the discontinuance of services and requested the Commission cancel its certificate of service authority and accompanying tariffs to provide telecommunications services in the State of Missouri.

In File Number TA-2013-0464, the Commission granted TNCI a certificate of service authority to provide telecommunications services in the State of Missouri, and approved its tariffs. Specifically TNCI was approved to provide basic local, nonswitched local, and interexchange telecommunications services. The Company's tariffs, P.S.C. MO No. 1, 2, and 3 were also approved.

On September 20, 2016, the Commission issued an Order Directing Staff to File a Recommendation. On September 30, 2016, Staff filed its recommendation and stated that TNCI notified the Commission that TNCI no longer wished to retain its certification to provide telecommunications in Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide telecommunications services and the company's accompanying tariffs.


The Commission has the authority to cancel a certificate and tariffs pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on TNCI’s request and Staff’s recommendation, the Commission finds that the certificate of service authority and accompanying tariffs granted to TNCI Operating Company, LLC, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide basic local, nonswitched local and interexchange telecommunications services granted to TNCI Operating Company, LLC, in File Number TA-2013-0464, is canceled.
2. TNCI Operating Company, LLC’s tariff, P.S.C. MO No. 1 is canceled.
3. TNCI Operating Company, LLC’s tariff, P.S.C. MO No. 2 is canceled.
4. TNCI Operating Company, LLC’s tariff, P.S.C. MO No. 3 is canceled.
5. This order shall become effective on November 5, 2016.
6. This case may be closed on November 6, 2016.
