MOTION FOR EXTENSION OF TIME FOR RESPONSE

COMES NOW Neutral Tandem-Missouri, LLC (Neutral Tandem), through undersigned counsel, and moves for the Commission to allow an additional 21 days, until October 19, 2009, for Neutral Tandem's response, and responses of other parties, to AT&T's Motion to Suspend and Investigate Tariff (AT&T's Motion). In support of this motion, Neutral Tandem states as follows:

1. Neutral Tandem seeks to address concerns raised in AT&T's Motion through discussions with AT&T. However, those discussions cannot be conducted in the time frame provided for Neutral Tandem's response by the Commission's September 21, 2009, Order Setting Time for Response.

2. To accommodate additional time for discussions with AT&T and Staff, Neutral Tandem has extended the effective date of its proposed tariff for 21 days, to October 29, 2009. A copy of the EFIS confirmation email is attached hereto.

3. Neutral Tandem requests a 21-day extension of time for its response, to October 19, 2009, and requests the extension apply to all responses, including Staff's.

4. Undersigned counsel has spoken with counsel for AT&T and Staff regarding this request. They do not object to this request, contingent on a commensurate extension of the tariff effective date.

5. Grant of this motion will facilitate the parties' attempts to resolve concerns regarding Neutral Tandem's tariff.

WHEREFORE, Neutral Tandem-Missouri, LLC, respectfully requests the Commission extend the time for responses to AT&T's Motion to Suspend and Investigate Tariff to October 19, 2009.
