**ORDER APPROVING TARIFFS IN COMPLIANCE
WITH COMMISSION ORDER**

Effective Date: November 28, 2014

On October 29, 2014, Peaceful Valley Service Company ("Peaceful Valley") submitted replacement tariffs (Tracking Nos. YS-2015-0185 and YW-2015-0186). Peaceful Valley stated the replacement tariffs are intended to comply with the rates approved by the Commission in its October 8, 2014 Report and Order. The tariff sheets have a November 28, 2014 effective date. Peaceful Valley requested the Commission approve the replacement tariffs in an expedited manner. The Commission directed the Staff of the Commission to file a recommendation on the tariff sheets and set a deadline for objections to the tariff sheets.

On October 30, 2014, Staff filed a recommendation stating the tariffs are compliant with the Commission's Report and Order and recommending the Commission approve the tariff expeditiously. The Commission set a November 10, 2014 deadline for entities to object to Staff's recommendations. No objections were received.

Although Peaceful Valley requested the Commission approve the replacement tariffs in an "expedited manner," no specific request was made for an earlier effective

date. Therefore, the Commission will approve the tariff sheets, with an effective date of November 28, 2014.
