ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFFS

Issue Date: December 9, 2016 Effective Date: December 19, 2016

On September 9, 2016, the Staff of the Missouri Public Service Commission filed a motion requesting Magnum Networks, LLC's ("Magnum") certificate of service authority and accompanying tariffs to provide basic local and interexchange telecommunication service in the State of Missouri be cancelled.

In File Number LA-2015-0283, the Commission granted Magnum a certificate of service authority to provide basic local and interexchange telecommunication service in the State of Missouri. The Company's tariffs, P.S.C. Mo No. 1 and 2, were also approved.

Staff stated in its motion that Magnum's Bankruptcy Trustee notified the Commission that Magnum was no longer in business. Staff recommends that the Commission cancel the company's certificate of service authority to provide basic local and interexchange telecommunications services, and the company's accompanying tariffs.

On September 12, 2016, the Commission issued an Order Establishing Time to Respond allowing parties until September 22, 2016, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariffs granted to Magnum Networks, LLC, shall be canceled.

THE COMMISSION ORDERS THAT:

- The certificate of authority to provide basic local and interexchange telecommunications services granted to Magnum Networks, LLC, in File Number LA-2015-0283, is canceled.
 - 2. Magnum Networks, LLC's tariffs, P.S.C. Mo No. 1 and 2, are canceled.
 - 3. This order shall become effective on December 19, 2016.
 - 4. This case may be closed on December 20, 2016.
