Thank you for being a loyal GRM Networks customer. As your local communications provider, we strive to continually provide excellent service at reasonable rates.

GRM Networks is partially funded by the Universal Service Fund (USF). Support from this fund allows rural communications companies, such as GRM Networks, to provide advanced communication services in much the same way as urban communication companies provide services to their customers.

Over the past few years, the Federal Communications Commission (FCC) has been implementing a plan requiring rural phone companies to price basic residential phone service rates to meet the national urban benchmark. GRM Networks will lose a large amount of USF support in lowa if the FCC mandate is ignored. To learn more about the USF, please visit our website at www.grm.net/usf.

As part of our continued mission to advocate on behalf of our customers, GRM Networks joined with other rural communications providers to discuss this price increase with our congressional representatives. The FCC did not remove the requirement to maintain pace with the urban rates for companies remaining on legacy support.

Effective June 1, 2017, the monthly charge for a residential line will be \$20.50. Monthly rates for bundled services that include the residential line charge and the off premise extension line charge will all increase by \$2.50.
