ORDER GRANTING INTERVENTION AND SETTING PREHEARING CONFERENCE

On August 23, 2018, Ameren Transmission Company of Illinois ("ATXI") asked the Commission for a Certificate of Convenience and Necessity (CNN) and any other approvals necessary to authorize ATXI to acquire certain electrical facilities owned by the City of Rolla, Missouri, and to own, operate, maintain, and control those facilities as well as adjacent facilities ATXI plans to construct as a part of a proposed network transmission solution. ATXI also requested expedited treatment of its application and requested Commission approval of its application by February 1, 2019.

On August 24, 2018, the Commission ordered the Missouri Public Service Commission's Data Center to serve notice and ordered that any person wishing to intervene in this matter file an application to do so no later than September 10, 2018. On August 31, 2018, the Missouri Department of Economic Development – Division of Energy ("DE") filed an application to intervene. No person or entity has filed any objection to DE's application to intervene. No other person or entity has filed an application to intervene.

The Commission will grant DE's application to intervene and will set a prehearing conference.

THE COMMISSION ORDERS THAT:

- 1. The application of the Missouri Department of Economic Development Division of Energy to intervene is granted. DE is made a party to these proceedings, and the Missouri Public Service Commission's Data Center is ordered to add DE to the certified service list for this file.
- 2. The prehearing conference shall be held on September 25, 2018, beginning at 10:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. That room is in a building that meets accessibility standards required by the Americans with Disabilities Act.
