AMENDED ORDER SUSPENDING TARIFF, DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, AND DIRECTING FILING OF STAFF RECOMMENDATION

On August 21, 2018, Missouri-American Water Company ("MAWC") filed P.S.C. Mo. No. 13, 2nd Revised Tariff Sheet No. R. 65 to replace the 1st Revised Tariff Sheet No. R. 65. The tariff has an effective date of September 20, 2018. The tariff sheet changes how MAWC accounts for income taxes that accrue from Contributions in Aid of Construction ("CAIC"). On September 11, 2018, The Staff of the Commission filed a motion requesting the Commission send notice to participants in MAWC's last rate case, WR-2017-0285. Staff also requested that the deadline for intervention be extended until October 17, 2018; that the due date for Staff to file a recommendation be extended until November 5, 2018; and that the tariff suspension be extended to December 7, 2018.

Because the tariff raises policy questions for the Commission regarding where the company should properly recoup taxes from for the receipt of CIAC, and because other interested stakeholders may have an interest in the outcome of any proceeding, the Commission will further suspend the tariff, issue notice to the participants in WR-2017-0285, extend the deadline for intervention requests, and extend the deadline for the Commission's Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

The tariff sheet filed by Missouri-American Water Company on August 21,
2018, and assigned tariff tracking number JW-2019-0019, is further suspended until
December 7, 2018. The tariff sheet suspended is:

2. The Commission's Data Center shall send this notice and order to everyone certified or on the subscriber participant list in File No. WR-2017-0285.

3. Any application for intervention shall be filed no later than October 17, 2018.

4. The Commission's Staff shall file a recommendation regarding Missouri-

American Water Company's tariff filing no later than November 5, 2018.

5. This order shall be effective when issued.
