## ORDER CANCELING CERTIFICATES AND ACCOMPANYING TARIFF

Issue Date: September 17, 2009

Effective Date: September 27, 2009

On August 26, 2009, the Staff of the Missouri Public Service Commission filed a motion requesting KR&R Investment Corp. d/b/a Uplink's ("Uplink") certificates of service authority and accompanying tariffs to provide intrastate interexchange and shared tenant telecommunication services in the State of Missouri be cancelled.

In File Number TA-98-408, the Commission granted Uplink a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved. In File Number TA-98-407, the Commission granted Uplink a certificate of service authority to provide shared tenant telecommunications services in the State of Missouri.

Staff states in its motion that Uplink notified Staff that the company ceased business, has had no revenues or expenses in the past twenty months, and has requested their certificates and tariff be canceled. Uplink is deficient in the filing of the Company's calendar year 2008 annual report. Uplink is current in the payment of its assessments to the Commission. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate

interexchange and shared tenant telecommunications services, and the company's accompanying tariff.

On August 28, 2009, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than September 8, 2009. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificates of service authority and accompanying tariff granted to KR&R Investment Corp. d/b/a Uplink, shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to KR&R Investment Corp. d/b/a Uplink, in File Number TA-98-408, is canceled.
2. KR&R Investment Corp. d/b/a Uplink's tariff, P.S.C. Mo No. 1, is canceled.
3. The certificate of authority to provide shared tenant telecommunications services granted to KR&R Investment Corp. d/b/a Uplink in File Number TA-98-407, is canceled.
4. This order shall become effective on September 27, 2009.

5. This case may be closed on September 28, 2009.
