On September 20, 2016, the Commission's Staff filed a recommendation advising the Commission to approve Transource Missouri, LLC's application, subject to certain conditions. The Commission will direct Transource Missouri to respond to Staff's recommendation by indicating whether the conditions recommended by Staff are acceptable. The Commission will also allow other parties an opportunity to respond to Staff's recommendation if they wish to do so.

THE COMMISSION ORDERS THAT:

1. Transource Missouri, LLC shall respond to Staff's Recommendation no later than September 30, 2016
2. Any other party wishing to respond to Staff's Recommendation shall do so no later than September 30, 2016.
