Enclosed for filing is <u>P.S.C. MO. No. 5 Consolidated, Twenty-Fourth Revised Sheet No. 12,</u> which is applicable to the Laclede Division of Laclede Gas Company ("Company").

This revised tariff sheet, which has an issue date of January 30, 2015 and an effective date of March 2, 2015, is being filed to change the Infrastructure System Replacement Surcharge ("ISRS") in accordance with Sections 393.1009, 393.1012 and 393.1015 of the Revised Statutes of Missouri. A full explanation of the surcharge being proposed by the Company is set forth in the *Verified Application and Petition of Laclede Gas Company To Change Its Infrastructure System Replacement Surcharge in Its Laclede Gas Service Territory*, which is being filed separately today. As proposed herein, the ISRS would increase the typical residential heating customer's bill by 64 cents per month or less than 1%.

## INFRASTRUCTURE SYSTEM REPLACEMENT SURCHARGE ("ISRS")

Description: The ISRS is designed to recover the costs associated with the Company's eligible infrastructure replacements in accordance with the provisions of Sections 393.1009 to 393.1015, RSMo.

Applicability: In addition to the other charges provided for in the Company's tariff, a monthly ISRS shall be added to each customer's bill for service rendered on and after the effective date of the ISRS.
