# ORDER CLARIFYING HEARING SCHEDULE

On October 11, 2016, the Office of the Public Counsel, on behalf of itself, Union Electric Company d/b/a Ameren Missouri, and the Commission's Staff filed a *Joint Statement of Contested Issues, List of Witnesses, Order of Cross-Examination, and Order of Opening Statements*.
