**ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF**

Issue Date: August 14, 2006

Effective Date: August 18, 2006

Electric Lightwave, LLC, submitted revised tariff sheets on July 3, 2006, designed to reflect that it will be operating under the "Doing Business As" name Intergra Telecom. Electric Lightwave's tariff had a proposed effective date of August 1, 2006. On July 6, 2006, the Missouri Public Service Commission issued an order directing Electric Lightwave to correct deficiencies in its application. Electric Lightwave voluntarily suspended its tariff until September 1, 2006, and updated its filing to bring it into compliance with Commission rules.

The Commission Staff filed a recommendation on August 11, 2006, stating that it had reviewed the company's tariff and recommending that the Commission issue an order recognizing the name change and approving the tariff sheets filed to effectuate that name change with an effective date of August 18, 2006, or as soon as possible thereafter.

The Commission has reviewed Electric Lightwave's tariff filing and Staff's verified recommendation, which are hereby admitted into evidence, and finds that Electric Lightwave's name change should be recognized. The Commission further finds that the tariff sheets should be approved.

**IT IS ORDERED THAT:**

1. The Commission recognizes the adoption by Electric Lightwave, LLC, of the fictitious name Electric Lightwave, LLC, d/b/a Integra Telecom.

2. The tariff filed by Electric Lightwave, LLC, d/b/a Integra Telecom, on July 3, 2006, and assigned tariff number YX-2007-0003, is approved to become effective on August 18, 2006. The tariff approved is:
