ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 9, 2018 Effective Date: January 19, 2018

On December 26, 2017, the Staff of the Missouri Public Service Commission filed a motion requesting Residential Long Distance, Inc.'s ("RLDI") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunications service in the State of Missouri be cancelled. In File Number TO-2011-0386, the Commission granted RLDI a certificate of service authority to provide intrastate interexchange telecommunications service in the State of Missouri. The Company's tariff, YX-2014-0125, was also approved.

Staff states in its motion that on November 17, 2017, the RLDI notified the Commission that it no longer wished to retain its certification to provide interexchange telecommunications services in Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On December 27, 2017, the Commission issued an Order Establishing Time to Respond allowing parties until January 6, 2018, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to RLDI Communications Company, shall be canceled.

THE COMMISSION ORDERS THAT:

- The certificate of authority to provide intrastate interexchange telecommunications services granted to Residential Long Distance, Inc. in File Number TO-2011-0386, is canceled.
 - 2. Residential Long Distance, Inc.'s tariff, YX-2014-0125, is canceled.
 - 3. This order shall become effective on January 19, 2018.
 - 4. This case may be closed on January 20, 2018.
