ORDER AND NOTICE

On August 23, 2018, Ameren Transmission Company of Illinois (“ATXI”) asked the Commission for a Certificate of Convenience and Necessity (CNN) and any other approvals necessary to authorize ATXI to acquire certain electrical facilities owned by the City of Rolla, Missouri, and to own, operate, maintain, and control those facilities as well as adjacent facilities ATXI plans to construct as a part of a proposed network transmission solution. ATXI also requested expedited treatment of its application and requests Commission approval of its application by February 1, 2019.

The Commission finds that notice of the application should be given to the general public and interested parties and a date for intervention of proper parties should be set. The Commission’s Data Center shall mail a copy of this notice to the County Commission of Phelps County. Additionally, the Commission’s public information officer shall make notice of this order available to the media serving Phelps County and to the members of the General Assembly representing Phelps County.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party or governmental entity is

granted intervention, and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary for a determination on the application.¹

THE COMMISSION ORDERS THAT:

1. The Missouri Public Service Commission's Data Center is ordered to serve notice as described in the body of this order.
2. The Missouri Public Service Commission's public information officer is ordered to serve notice as described in the body of this order.
3. Any proper person wishing to intervene in this matter shall file an application no later than September 10, 2018. Such applications shall be filed with:


