ORDER CANCELING CERTIFICATE
AND ACCOMPANYING TARIFF

Issue Date: April 14, 2006

Effective Date: April 24, 2006

On April 3, 2006, Nationwide Professional Teleservices, LLC ("NPT") filed a motion asking the Commission to cancel its certificate of service authority to provide interexchange telecommunication service in Missouri. NPT also asks the Commission to cancel the tariff associated with that certificate.

In Case Number XA-2005-0130, the Commission granted NPT a certificate of service authority to provide interexchange telecommunication service. NPT's tariff, PSC MO No. 1, was approved in the same case. NPT states it has no customers in Missouri and no longer intends to provide telecommunications service in Missouri. NPT further states they do not have any pending actions concerning customer service or rates against it and does not have any overdue annual reports or assessment fees.

The Staff of the Commission filed a recommendation on April 10, 2006, regarding NPT's request to cancel its certificate and tariff. Staff indicates that it has no objection to NPT's request. Staff further indicates the cancellation of NPT's certificate is not detrimental to the public interest. Staff recommends that the

Commission cancel the company's certificate of service authority to provide interexchange telecommunications service and its accompanying tariff.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the application and the recommendation of its Staff, the Commission finds that the certificate of service authority and accompanying tariff granted to NPT shall be canceled.

IT IS ORDERED THAT:

1. The certificate of service authority to provide interexchange telecommunications service, granted to Nationwide Professional Teleservices, LLC, in Case Number XA-2005-0130, is canceled.
2. Nationwide Professional Teleservices' telecommunications tariff, P.S.C. MO No. 1, is canceled.
3. This order shall become effective on April 24, 2006.
4. This case may be closed on April 25, 2006.
