ORDER CANCELING CERTIFICATE AND TARIFF

Issue Date: April 25, 2006 Effective Date: May 5, 2006

This order cancels the certificate of service authority to provide intrastate interexchange telecommunications services granted to Quick Tel, Inc., along with its accompanying tariff.

On April 14, 2006, the Staff of the Commission filed a motion to open a case and to cancel Quick Tel's certificate of service authority and accompanying tariff. Staff's motion indicates that Quick Tel has contacted Staff and has requested that it be allowed to relinquish its certificate in Missouri. The company told Staff that it is not providing telecommunications service in Missouri. Staff confirms that the company owes no assessments or annual reports. The Staff also notes that no formal complaints have been filed with the Commission against Quick Tel since the commencement of the Electronic Filing and Information System.

The motion states that the Commission granted Quick Tel a certificate of service authority to provide intrastate interexchange telecommunications services in May 2001, in Case No. TA-2001-519. The company's interexchange tariff, Missouri P.S.C. Mo. Tariff No. 1, was approved in the same order.

Staff served copies of its motion on Quick Tel, and its registered agent, TCS Corporate Services, Inc., but the company has not filed a response.

The Commission has the authority to cancel a telecommunications corporation's certificate under Section 392.410.5, which states, "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." Since no one has requested a hearing, the Commission may grant the relief requested based on Staff's verified motion which is entered into evidence.

Based on Staff's uncontested motion, the Commission finds that Quick Tel's certificate and accompanying tariff should be canceled.

IT IS ORDERED THAT:

- 1. The certificate of service authority to provide intrastate interexchange telecommunications services granted to Quick Tel, Inc., in Case No. TA-2001-519, is canceled.
- 2. Quick Tel, Inc.'s intrastate interexchange tariff, Missouri P.S.C. Mo. Tariff No. 1, is canceled.

- 3. This order shall become effective on May 5, 2006.
- 4. This case may be closed on May 6, 2006.
