44.22.3 Additional Discounts

Residential ADL Retention Offer - On July 27, 2008, a retail discount of \$10.00 per month shall be established for residence customers who have more than one access line, call to disconnect an additional line, then decide to retain the additional line. Customers must already subscribe to or newly purchase Select Feature Package. Customers must keep the required services for 30 days to receive the benefit of this offer. On or after January 1, 2009, the customer may qualify for this offer by maintaining their existing Select Feature Package or newly purchase Complete Choice® Enhanced. Applicable nonrecurring installation charges associated with feature installation and package installation will also be waived. The customer's bill will be credited each month that the line and package are retained. If the customer disconnects the additional line, the package, or the additional line and package before the next bill period date in which a credit is due, any further discounts will cease. If the customer moves from their current location, any further discounts will cease. This discount is available on a maximum of one additional line and cannot be combined with any other access line retention offers that provide a monthly recurring discount.

- (1) The difference between this price and the Select Feature Package with Caller ID price may be reflected on the customer's bill as a credit. No credit is given if the customer deselects Caller ID.
- (2) Residence customers with Lifeline Service will pay a package rate that reflects the difference between their monthly recurring Lifeline rate and the monthly recurring line rate for a basic exchange access line.
