ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: February 21, 2014

Effective Date: March 3, 2014

On February 7, 2014, the Staff of the Missouri Public Service Commission filed a motion requesting Reunion Communications, Inc. ("Reunion") certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled.

In File Number YX-2011-0352, the Commission granted Reunion a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Reunion contacted Staff via letter stating Reunion was in the process of withdrawing its corporate registration with Missouri and requested the Commission cancel Reunion's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On February 10, 2014, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than February 20, 2014. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Reunion Communications, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Reunion Communications, Inc., in File Number YX-2011-0352, is canceled.
2. Reunion Communications, Inc.’s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on March 3, 2014.

4. This case may be closed on March 4, 2014.
