ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: May 4, 2016

Effective Date: May 14, 2016

On April 12, 2016, the Staff of the Missouri Public Service Commission filed a motion requesting Zoom-I-Net Communications, Inc.'s ("Zoom-I-Net") certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XA-2005-0314, the Commission granted Zoom-I-Net a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 2, was also approved.

Staff states in its motion that on May 19, 2015, Zoom-I-Net contacted Staff via letter stating Zoom-I-Net was no longer providing service in Missouri and requesting the Commission cancel Zoom-I-Net's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On April 14, 2016, the Commission issued an Order Establishing Time to Respond allowing any parties until April 25, 2016, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion and the company’s request, the Commission finds that the certificate of service authority and accompanying tariff granted to Zoom-I-Net Communications, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Zoom-I-Net Communications, Inc., in File Number XA-2005-0314, is canceled.
2. Zoom-I-Net Communications, Inc.’s tariff, P.S.C. Mo No. 2, is canceled.
3. This order shall become effective on May 14, 2016.

4. This case may be closed on May 15, 2016.
