ORDER CANCELING AUTHORITY

Issue Date: July 24, 2023

Effective Date: August 23, 2023

On March 24, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the certificate of service authority and applicable tariff of Opex Communications, Inc. (Opex or The Company). The Commission granted Opex a certificate to provide interexchange and non-switched local telecommunications in Case No. TA-2000-0030.

Staff's motion states that Opex failed to file an annual report for calendar years 2020 and 2021. Opex also failed to file its Statement of Revenue for calendar year 2020, and failed to pay its annual assessment for fiscal years 2020, 2022, and 2023. Staff recommended that the Commission cancel the Company's registration.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. The Company has not responded.

Based on Staff's motion, the Commission finds that the certificate granted to Opex and the accompanying tariff shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of service authority to provide interexchange and non-switched local telecommunications service granted to Opex in Case No. TA-2000-0030 is canceled.
2. The accompanying tariff, File No. JX-2003-0769, is cancelled.
3. This order shall become effective on August 23, 2023.
4. This case may be closed on August 24, 2023.
