- a. <u>Information Required</u>. When applying for interexchange service, each prospective customer will be required to furnish POPP TELCOM the following information:
  - .01 Name of the party who will be responsible for payment for the interexchange service provided.
  - .02 Address or exact location of the premises where interexchange service is to be provided and billed.
  - .03 Any information required to make a proper determination of appropriate credit worthiness.
- b. <u>Selection of Service Type.</u> POPP TELCOM offers several different types of service and multiple features for those services. The customer is responsible for the selection of the service and the features.
- c. <u>Change of Service</u>. Customers may change the service received and transfer to another service otherwise available to them. In such a case, the customer shall pay no one-time setup fee for the new service but shall not otherwise be entitled to any credits or remission from charges.
- d. <u>Additional Lines Required.</u> When POPP TELCOM interexchange service to the public is impaired by a customer's use of telephone service, POPP TELCOM shall have the right to require the customer to contract for and properly attend as many additional telephone lines as are needed to adequately serve the customer's requirements, or to discontinue the service of the customer in question.
- e. <u>Initiation of Service</u>. Service shall be considered initiated hereunder upon the earlier of the following:

- a. Requirement. POPP TELCOM may require from any customer or prospective customer, who has not established good credit with POPP TELCOM a deposit to be held as a guarantee for the payment of charges. POPP TELCOM will explain in writing why any deposit is required and under what conditions the deposit will be diminished upon return. Any applicant who is not a previous customer of POPP TELCOM having established good credit with POPP TELCOM may be required to pay a deposit. POPP TELCOM will consider only criteria which bears a reasonable relationship to assurance of payment as authorized by the Public Service Commission of the State of Missouri.
- b. <u>Amount.</u> The amount of the deposit shall not be more than the total of two months tariffed services. The amount of tariffed services may be estimated from past toll usage, customer estimated anticipated usage or POPP TELCOM state average toll usage considering type and nature of service.
- c. <u>Existing Customer.</u> An existing customer may be required to make a deposit or to increase a deposit presently held when a deposit is inadequate to cover two months interexchange service.
- d. Handling of Deposits. Deposits shall be sent to POPP TELCOM INCORPORATED, 620 Mendelssohn Avenue, Golden Valley, MN 55427. POPP TELCOM will maintain records which show the name and address of each depositor, the amount and date of the deposit, and each transaction concerning the deposit. Unclaimed deposits together with accrued interest shall be credited to an appropriate account and shall be disposed of in accordance with the law.
- e. <u>Receipts.</u> A receipt of deposit will be furnished to each customer from whom a deposit is received. Upon customer request, duplicate receipts will be provided to customers who have lost their receipt if the deposit is substantiated by POPP TELCOM records.
- f. <u>Customer Obligations</u>. The fact that a deposit has been made in no way relieves the customer from complying with POPP TELCOM regulations as to the prompt payment of bills.
