## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: March 6, 2018 Effective Date: March 16, 2018

On February 13, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting iNetworks Group, Inc.'s ("iNetworks") certificate of service authority and accompanying tariff to provide interexchange, basic local exchange, and switched exchange access telecommunication service in the State of Missouri be cancelled.

In File Number LO-2011-0021, the Commission granted iNetworks a certificate of service authority to provide interexchange, basic local exchange, and switched exchange access telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that iNetworks is deficient in the filing of the Company's annual report for calendar year 2017. Staff's email to the Company failed to be sent because the email address could not be found. Staff was informed by a prior known associate of the Company that the Company was administratively dissolved on February 15, 2017 for failure to file its registration with the Missouri Secretary of State. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange, basic local exchange and

switched exchange access telecommunications services, and the company's accompanying tariff.

On February 16, 2018, the Commission issued an Order Establishing Time to Respond allowing parties until February 26, 2018, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to iNetworks Group, Inc., shall be canceled.

#### THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide interexchange, service authority, basic local exchange telecommunications service and switched exchange access services granted to iNetworks Group, Inc., in File Number LO-2011-0021, is canceled.
  - 2. iNetworks Group, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
  - 3. This order shall become effective on March 16, 2018.

4. This case may be closed on March 17, 2018.
