# **ORDER APPROVING TARIFFS**

Issue Date: January 29, 2007 Effective Date: February 3, 2007

In an order issued October 26, 2006, the Commission granted Lake Region Water & Sewer Company a certificate of public convenience and necessity to provide water and sewer services to an expanded service area in a portion of Camden County, Missouri. That order directed Lake Region Water & Sewer to submit new and revised tariffs sheets to implement the authorized expansion. Lake Region Water & Sewer filed implementing tariffs on January 4, 2007, with an effective date of February 3. The Company filed substitute tariff sheets on January 9 and 18.

The Commission's Staff filed a recommendation regarding the proposed tariffs on January 26. Staff indicates that the submitted tariffs comply with the order that granted Lake Region Water & Sewer a certificate. Staff recommends that the Commission approve the submitted tariffs, to be effective on February 3.

Based on the recommendation of its Staff, the Commission will approve the submitted tariffs.
