ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY AND TARIFF

On October 2, 2018, the Staff of the Missouri Public Service Commission (the “Staff”) filed a motion requesting that the Commission cancel the certificate of interexchange service authority of NobelTel, LLC (the “Company”). Staff’s motion stated that the Company had notified the Commission by letter filed on August 23, 2018, that it wished to voluntarily relinquish its authority and to have all its applicable tariffs cancelled. The motion stated that the Company had stated that it had no prescribed customers and so customer notice was unnecessary. The Commission previously granted a certificate to the Company on November 8, 2002, to provide intrastate interexchange service authority in Case No. XA-2003-0119. The Company has a currently effective tariff, Tariff No. JX-2003-1049.

On October 3, 2018, the Commission issued its order that anyone wishing to respond to Staff’s Motion or request a hearing do so by filing a pleading no later than October 13, 2018. There were no such filings. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party

requests such a hearing.¹ Therefore, the Commission may cancel the certificate based on Staff's motion.

THE COMMISSION ORDERS THAT:

1. The certificate of interexchange service authority of NobelTel, LLC to provide service in the State of Missouri is herewith cancelled.
2. NobelTel, LLC's Tariff No. JX-2003-1049 is herewith cancelled.
3. This Order shall be effective when issued.
4. This file shall be closed.
