ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: May 27, 2009

Effective Date: June 6, 2009

On April 14, 2009, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and the accompanying tariff of The Dodson Group, Inc. ("Dodson"), a company that has been authorized to offer competitive interexchange telecommunication services by the Commission.

In File Number XA-2005-0009, the Commission granted Dodson a certificate of service authority to provide competitive interexchange telecommunications services. The Commission also approved the company's tariff, Mo. P.S.C. Tariff No. 1.

Staff's motion states that on April 7, 2009, the Commission received a ceasing operations statement from the Company requesting the Commission cancel their certificate and tariff. Dodson indicated they had ceased operations in the St. Louis, Missouri area on December 10, 2008, due to lack of continuing

customers. Staff further stated the company owes no past assessments to the Commission.

Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, Mo. P.S.C. Tariff No. 1, to provide competitive interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request and Staff's motion to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to The Dodson Group, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide competitive interexchange telecommunications services granted to The Dodson Group, Inc., in File Number XA-2005-0009, is canceled.

2. The Dodson Group, Inc.'s tariff, Mo. P.S.C. Tariff No. 1, granted in File No. XA-2005-0009, is canceled.

3. This order shall become effective on June 6, 2009.
4. This file may be closed on June 7, 2009.
