## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: June 17, 2011 Effective Date: June 27, 2011

On May 12, 2011, the Zayo Fiber Solutions, LLC ("Zayo") filed an application requesting its certificate of service authority and accompanying tariff to provide non-switched local exchange and interexchange telecommunication services in the State of Missouri be cancelled.

In File Number CA-2008-0306, the Commission granted Zayo a certificate of service authority to provide in the State of Missouri<sup>1</sup>. In File Number XN-2011-0026, the Commission granted the amendment to the certificate of service authority to reflect a name change to Zayo. The Company's tariff, P.S.C. MO No. 1, was also approved.

On May 12, 2011, Staff filed a response indicating it has no objections to Zayo's application for cancellation and withdrawal of the Company's certificate and accompanying tariff.

On May 16, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than May 26, 2011. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Zayo has never provided telephone service in Missouri and indicated that due to a proposed intra-corporate *pro forma* merger, with Zayo being the surviving company, Zayo has no intention of providing service in Missouri in the future.

Based on Zayo's request and Staff's response, the Commission finds that the certificate of service authority and accompanying tariff granted to Zayo Fiber Solutions, LLC, shall be canceled.

## IT IS ORDERED THAT:

- 1. The certificate of authority to provide non-switched local exchange and interexchange telecommunications services granted to Zayo Fiber Solutions, LLC, in File Number CA-2008-0306 and XN-2011-0026, is canceled.
  - 2. Zayo Fiber Solutions, LLC's tariff, P.S.C. MO No. 1, is canceled.
  - This order shall become effective on June 27, 2011.

4. This case may be closed on June 28, 2011.
