On May 3, 2016¹, the Commission issued an Order Approving Stipulation and Agreement ("The Agreement"). That order directed Missouri-American Water Company ("MAWC") to file tariffs that comport with The Agreement. The Agreement requires MAWC to adopt the existing Woodland Manor Water Company, LLC's water tariff, including its rates, rules and service area.

MAWC filed such tariffs on June 28. On June 29, the Staff of the Commission recommended that the Commission approve the tariffs.

The Commission has authority to approve tariff sheets pursuant to Sections 393.140(11) and 393.150, RSMo. The Commission has reviewed the tariff sheets and Staff's recommendation. The Commission finds that the tariff sheets conform to the Commission's May 3 order, and should be approved.
