ORDER CANCELLING CERTIFICATE AND TARIFF
AND CLOSING CASE

Issue Date: August 3, 2005

Effective Date: August 13, 2005

This order cancels the certificate of service authority and tariff of Dancris Telecom, LLC.

On August 1, 2005, the Staff of the Missouri Public Service Commission moved to cancel the certificate of service authority and tariff of Dancris Telecom, LLC. In support thereof, Staff states that this Commission granted Dancris, an Arizona limited liability corporation, a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri in September 2001, in Case No.TA-2002-116. The Commission also approved Dancris' tariff, P.S.C. MO Tariff No. 1, in the same case.

Staff further states that Dancris' website now displays a notice stating that its assets have been transferred to Andiamo Telecom, LLC. Personnel employed by Andiamo informed Staff that Dancris no longer exists. Although Dancris' telephone number is still a working number and mail sent to Dancris' address is not returned, Staff has been unable to elicit any response from the company. Staff does not believe that Dancris presently has any Missouri customers. Staff states that Dancris has not paid its minimal estimated assessment for 2005 and has not submitted its annual report for 2004.

Staff urges the Commission to cancel Dancris' certificate and tariff because it does not respond to Staff's inquiries and appears to no longer be operating.

The Commission finds that Dancris' certificate and tariff should be cancelled because the company does not respond to Staff's inquiries and it may no longer be operating.

IT IS THEREFORE ORDERED:

1. That the Motion to Open Case and Cancel Certificate of Service Authority and Accompanying Tariff, filed on August 1, 2005, by the Staff of the Missouri Public Service Commission, is granted.
2. That the certificate of service authority granted to Dancris Telecom, LLC, in September 2001, in Case No. TA-2002-116, is cancelled.
3. That the tariff of Dancris Telecom, LLC, approved in September 2001, in Case No. TA-2002-116, is cancelled.
4. That this order shall become effective on August 13, 2005.
5. That this case may be closed on August 14, 2005.
