## ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: January 20, 2017 Effective Date: January 28, 2017

The Commission issued a *Report and Order* on January 18, 2017, authorizing Laclede Gas Company to submit tariff sheets to adjust its Infrastructure System Replacement Surcharge (ISRS) in both its Laclede and its Missouri Gas Energy (MGE) service territories. Laclede Gas Company was directed to file its compliance tariff sheets no later than 1:00 p.m., January 19, 2017. Laclede Gas Company filed tariff sheets (Tariff Nos. YG-2017-0148 and YG-2017-0147) to comply with the Commission's *Report and Order*. The tariff sheets had a February 18, 2017 effective date, but Laclede Gas Company requested that the tariff sheets go in to effect on January 28, 2017.

The Commission issued an order setting a January 20, 2017 deadline for the filing of objections to the requests for a January 28<sup>th</sup> effective date. No objections were received.

On January 20, 2017, the Staff of the Commission filed recommendations stating that the rates in both the Laclede and MGE tariff sheets comply with those authorized in the Commission's *Report and Order*. The Staff also recommended the Commission approve Laclede's ISRS tariff sheet to go into effect on January 28, 2017 in order to be consistent with the 120-day procedure set out by Section 393.1015.2(3).

The Commission finds that Laclede's tariff sheets comply with the Commission's January 20, 2017 *Report and Order* and will approve it. Section 393.140(11), RSMo 2000, provides that the Commission may permit a tariff to take effect on less than thirty-days' notice upon a showing of good cause. The Commission concludes that good cause for an expedited effective date exists in these matters because no party has objected, there has already been a hearing on the substantive issues contained in the tariff sheets, the Commission Staff recommends the tariff sheets become effective on January 28<sup>th</sup>, and the statutory scheme of the ISRS sets out a fairly expedited procedure with the 120<sup>th</sup> day being January 28, 2017.
