ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: February 21, 2018 Effective Date: March 3, 2018

On February 21, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting Intellicall Operator Services, Inc., d/b/a ILD's ("ILD") certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri be cancelled.

In File Number TA-92-210, the Commission granted the company a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. In File No. XN-2003-0149, the Company was granted authority to change its name to ILD. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that ILD contacted Staff stating ILD no longer wished to retain its certificate to provide interexchange telecommunications services in Missouri. The Company further requested the Commission cancel all authority to provide telecommunications services under the names Intellicall Operator Services, Inc. and Intellicall Operator Services, Inc., d/b/a ILD. Staff recommends that the Commission cancel the company's certificate of service authority to provide

interexchange telecommunications services, and the company's accompanying tariff.

On February 2, 2018, the Commission issued an Order Establishing Time to Respond allowing parties until February 13, 2018, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Intellicall Operator Services, Inc., d/b/a ILD, shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide interexchange telecommunications services granted to Intellicall Operator Services, Inc., d/b/a ILD, in File Number TA-92-210 and XN-2003-0149, is canceled.
- 2. Intellicall Operator Services, Inc., d/b/a ILD's tariff, P.S.C. Mo No. 1, is canceled.
 - This order shall become effective on March 3, 2018.

4. This case may be closed on March 4, 2018.
