**REQUEST FOR EXTENSION OF TIME**

Electric Lightwave, LLC ("ELI" or "Applicant"), by and through undersigned counsel and in response to the Commission's Order Directing Filing ("Order") issued July 6, 2006, respectfully requests additional time to provide one of the documents required by the Commission. Specifically, the Order requires Applicant to file two additional documents by July 14, 2006: (1) evidence that the "doing business as" name Integra Telecom has been registered with the Secretary of State, and (2) revised tariff pages.


Applicant has already submitted revised tariff pages (as directed by Staff), therefore ELI has already satisfied this request for additional documents.<sup>1</sup> For certain corporate reasons, however, Applicant anticipates that it may not be possible for registration of the "doing business as" name to be filed with the Secretary of State until on or about August 1, 2006. Accordingly, while Applicant expects that it can provide proof of registration shortly thereafter, Applicant respectfully requests a one (1) month extension of time, to August 14, 2006, to ensure that Applicant can comply with this requirement.

<sup>1</sup> Applicant understands that the effective date for the revised tariff pages depends on the date Applicant submits proof to the Commission that the registration of the Integra Telecom name has been obtained from the Missouri Secretary of State. Applicant further understands, however, that that effective date will be automatically generated by the Commission so that no additional tariff filing is required at this time. Applicant therefore requests a day-for-day extension to the effective date of its tariff adoption notice.

Applicant respectfully submits that good cause exists for the extension requested herein. In particular, as set forth in the Application, Applicant expects the proposed change in operating name will allow the combined ELI/Integra companies to more seamlessly promote and market their services and prevent customer confusion. The requested extension of time will ensure that Applicant can complete the process of registering the proposed operating name.
