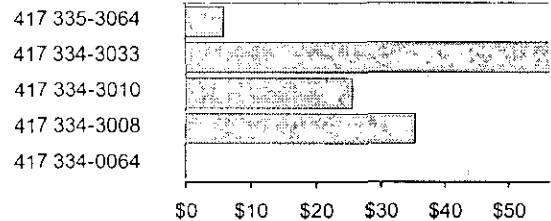

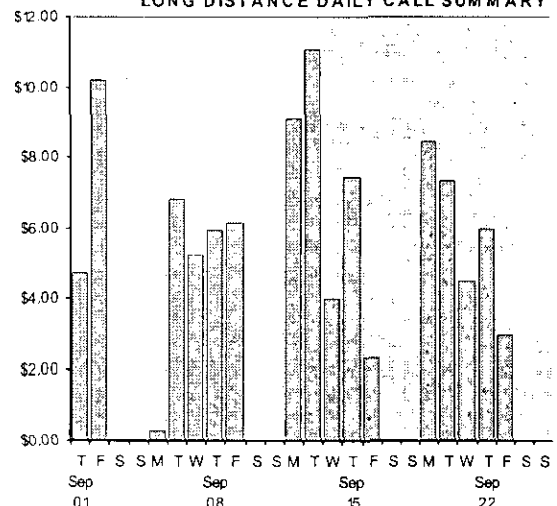

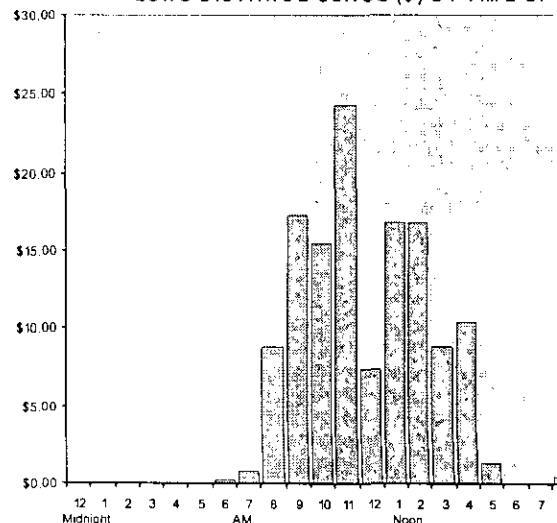
LONG DISTANCE USAGE BY LINE
