On June 2, 2015, AT&T, Inc. ("AT&T") notified Lathrop Telephone Company ("Lathrop") that it planned to terminate the interconnection agreement between AT&T's affiliate Cricket Communications, Inc. ("Cricket") and Lathrop. According to AT&T's letter, Cricket will continue to operate in Missouri as an affiliate of New Cingular Wireless PCS ("Cingular") and exchange traffic with Lathrop under the Cingular interconnection agreement. Re: Termination of Cricket Interconnection Agreement

Dear Mr. Meyers:

Upon consummation of the Merger Agreement between AT&T Inc. ("AT&T") and Leap Wireless International, Inc. ("LWI"), LWI became an indirect wholly-owned subsidiary of AT&T, as did the operating subsidiaries of LWI, including Cricket Communications, LLC ("Cricket") (fka Cricket Communications, Inc.). Both LWI and Cricket are now operating affiliates of New Cingular Wireless PCS, LLC ("New Cingular").

AT&T intends to continue to operate Cricket under that name as an affiliate of New Cingular and to terminate all interconnection agreements between Cricket and all other wireline and wireless carriers.

Once those agreements are terminated, all traffic exchanged between Cricket, and other carriers will be governed by the current interconnection agreements between New Cingular and those other carriers.

Many of those current interconnection agreements are in the name of "New Cingular Wireless PCS, LLC and its commercial radio service operating affiliates, d/b/a AT&T Mobility." Because Cricket will continue doing business under its own name, this letter will serve as formal written notice that New Cingular Wireless PCS, LLC will no longer be doing business solely under the name of AT&T Mobility.

This letter will also serve as formal written notice that AT&T will terminate the interconnection agreement between Cricket and Lathrop Telephone Company on December 31, 2015.
