#### NOTICE OF UPDATED RESIDENTIAL RATE OPTIONS SUMMARY SHEET

**COMES NOW** Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), and for its *Notice of Updated Residential Rate Options Summary Sheet* states as follows:

1. All parties to this case engaged in g o o d f a i t h settlement discussions, and on February 28, 2020, filed a Non-Unanimous Stipulation and Agreement resolving all but two issues raised by the Office of Public Counsel. On March 3, 2020, the parties submitted a Corrected Non-Unanimous Stipulation and Agreement (hereinafter "Stipulation") to correct two small items in the February 28, 2020 Stipulation and Agreement. The only party that did not sign the Stipulation indicated that it did not object to the Stipulation, so the Commission's rules allow it to be treated as a unanimous stipulation.<sup>1</sup>

2. On March 4, 2020, the Parties appeared for an on-the-record presentation of the Stipulation ("OTR").

3. During the March 4, 2020 OTR, Ameren Missouri provided a one-page summary of the Residential Rate Options, and Chairman Silvey asked that the one-page summary of the Residential Rate Options be updated with the final rates calculated pursuant to the Stipulation and filed in this Docket.

4. The attached one-page summary of the Residential Rate Options has been updated with the final rates calculated pursuant to the Stipulation, and is hereby filed in this Docket.

WHEREFORE, Ameren Missouri requests that the Commission take notice of the attached

updated one-page summary of the Residential Rate Options.
