Dear Mr. Roberts:

On June 16, 2008, Broadview Networks, Inc. ("Broadview"), submitted in the above-referenced Case an original and fourteen (14) copies of its revised Missouri Telecommunications Tariff, M.P.S.C. No. 1. Through this tariff filing, Broadview sought to incorporate (at Sections 6 and 7 respectively), the rates and charges which would be applicable to customers of ATX Licensing, Inc., and A.R.C. Networks, Inc. d/b/a InfoHighway following the consolidation of these customers into the customer base of Broadview Networks, Inc. on or about September 1, 2008.<sup>1</sup>

In discussions with Commission Staff since that June 16<sup>th</sup> filing, Broadview has been advised to request withdrawal of all tariff pages submitted on June 16, 2008, and to replace that tariff submission with the present filing. Accordingly, Broadview hereby respectfully submits the following revised tariff pages, which bear an Issued date of July 1, 2008, and an Effective date of August 1, 2008:


