ORDER RECOGNIZING NAME CHANGE

On July 20, 2023, Windstream Services, LLC filed a letter informing the Commission that Earthlink Business, LLC had changed the name by which it provides telecommunications services in Missouri to Windstream New Edge, LLC. The letter stated that Earthlink Business, LLC has no active tariffs on file with the Commission.

On July 25, 2023, the Staff of the Commission filed a recommendation that the Commission recognize the name change, stating that Earthlink Business, LLC had filed all of the requisite documentation and complied with all other aspects of the rules set forth in Commission Rule 20 CSR 4240-28.011(2). No one has opposed the name change.

The Commission has reviewed the notice of name change and Staff's recommendation and will recognize the name change.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the change of name of Earthlink Business, LLC to Windstream New Edge, LLC.
2. This order shall be effective on August 31, 2023.
3. This file shall be closed on September 1, 2023.
