Staff will consider all suggested edits and comments received by December 28, 2009 during its preparation of an additional draft, if necessary, for distribution to you in early January 2010.

The on-the-record meeting for presentations before the Commission on the 4 CSR 240-22 Rule Revisions is scheduled for January 25, 2010 beginning at 8:30 AM in Room 310. This on-the-record meeting will be webcast.

Finally, I am including a worksheet which contains the analysis prepared by Staff to select the date for triennial compliance filings and annual update filings (see revised draft 4 CSR240-22.080(1)). When considering the interests of the utilities, Staff and stakeholders, Staff believes that April 1 is the best date for triennial compliance filings and annual update filings.
