RE: Trigen-Kansas City Energy Corporation

Dear Ms. Dale:

On behalf of Trigen-Kansas City Energy Corporation ("Trigen"), I am providing herewith to the Missouri Public Service Commission ("Commission") for filing in electronic form certain tariff sheets consisting of (A) revised steam rate schedules which are designed to increase Trigen's gross annual steam tariff revenues by approximately \$1,228,000, or 19.5%, exclusive of applicable gross receipts, sales, franchise or occupational fees or taxes, and (B) certain revised rules and regulations. The tariff sheets bear a date of issue of March 11, 2008, and an effective date of April 11, 2008.

The proposed rate increase is driven by several factors. Trigen has not adjusted its tariff rates since Kansas City Power & Light Company divested itself of the steam system in 1990; since that time, there have been significant changes in Trigen's fuel costs, operations and maintenance expenses, and net plant. Also, metering technology is in place today which better allows Trigen to implement demand based rates for its larger customers.

Also provided in electronic form is a letter from Brian P. Kirk, Trigen's Vice President and General Manager, which sets forth a list of the tariff sheets being filed and which explains the purpose of the filing. Also included are Trigen's Minimum Filing Requirements in electronic form, as required by 4 CSR 240-3.030(3)(B).

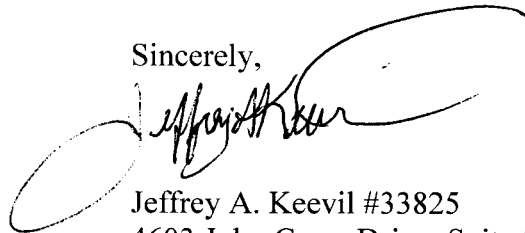
