Title 4—DEPARTMENT OF ECONOMIC DEVELOPMENT Division 240 – Public Service Commission Chapter 2 – Practice and Procedure

4 CSR 240-3.555 Telecommunications Company Residential Customer Inquiries. This rule set forth the procedures that were to be followed when residential customers made inquiries of telecommunications companies to ensure that such inquiries were handled in a reasonable manner.

PURPOSE: This rule is rescinded in its entirety because the subject matter is no longer within the Missouri Public Service Commission's authority as described in Section 392.611.
