**AT&T MISSOURI'S FILING OF THE FULLY CONFORMED INTERCONNECTION
AGREEMENT, AND STATEMENT OF COMPLIANCE**

COMES NOW AT&T Missouri¹ and, pursuant to Commission Rules 3.513 (4 CSR 240-3.513) and 36.050 (4 CSR 240-36.050), respectfully states:

1. On December 15, the Commission issued and filed in EFIS its Decision in this proceeding, in which the Commission approved the Arbitrator's November 29 Final Report.

2. On December 16, the Commission issued its Order Extending Time to File Conformed Agreement and Statements, in which it allowed AT&T Missouri and Global Crossing² through and including December 29, 2010, in which to file both their interconnection agreement (fully conformed to the Decision) and their compliance statements, which filings are required to be made pursuant to Commission Rule 36.050(1).

3. AT&T Missouri hereby files contemporaneously herewith the fully conformed interconnection agreement. Pursuant to Commission Rule 3.513(3)(B), all parties have signed the agreement and all pages of the agreement are sequentially numbered.

4. AT&T Missouri states that to the best of its knowledge, information and belief, the interconnection agreement filed herewith complies with the requirements of sections 251 and 252 of the federal Telecommunications Act.

5. Commission Rule 36.050(3) (4 CSR 240-36.050)(3)) provides that within thirty days after the filing of the conformed arbitration agreement, the Commission shall issue a decision approving or rejecting the agreement (including those parts arrived at through negotiations).

WHEREFORE, AT&T Missouri respectfully requests that the Commission accept and approve the parties' fully conformed interconnection agreement filed herewith.
