ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On July 22, 2016, Transource Missouri, LLC filed an application seeking an order declining jurisdiction, or, in the alternative, granting a Certificate of Convenience and Necessity pursuant to section 393.170, RSMo 2000. In response to that application, the Commission directed that notice of the application be given to potentially interested parties, and directed its Staff to file either a recommendation or a status report regarding Transource's application by August 23.

On August 24, Staff filed a status report, along with a request for leave to file that report a day late. The status report indicates Staff is investigating the application and expects to be able to file its recommendation by September 20. The Commission will accept Staff's status report a day late, and will direct Staff to file its recommendation by September 20.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation regarding Transource Missouri's application no later than September 20, 2016.

2. This order shall be effective when issued.
