**JOINT MOTION TO MODIFY PROCEDURAL SCHEDULE**

COME NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”), the Office of Public Counsel (“OPC” or “Public Counsel”), the Staff of the Missouri Public Service Commission (“Staff”), Brightergy, LLC (“Brightergy”), and United for Missouri, Inc. (“UFM”), the Missouri Department of Economic Development-Division of Energy (“DE”), and hereby file this *Joint Motion to Modify Procedural Schedule* as follows:

1. On June 24, 2016 the Missouri Public Service Commission (“Commission”) issued its order setting the procedural schedule in this case. According to that schedule, rebuttal testimony by non-company parties is due by August 18, 2016.
2. The parties to this proceeding have been conducting technical conferences and settlement discussions which continue to be productive. In order to provide more time to schedule further meetings and to facilitate additional discussions before rebuttal testimony is filed, the parties request the Commission modify the deadline for rebuttal testimony in the procedural schedule to August 25, 2016.
