On September 27, 2018, the Missouri Landowners Alliance filed a motion requesting that the Commission establish a procedural schedule regarding the receipt of any evidence that has materially changed since the filing of Grain Belt Express' previous direct testimony in this case. The Commission finds that a procedural conference is now appropriate to discuss filing deadlines for a procedural schedule, to include supplemental pre-filed testimony and a date for a supplemental evidentiary hearing.
