## ORDER ON DEADLINES FOR RESPONDING AND OBJECTING TO DATA REQUESTS

On October 3, 2018, the Commission issued its Order Adopting Procedural Schedule. The Commission will clarify its order for responding and objecting to data requests:

### THE COMMISSION ORDERS THAT:

1. With respect to Paragraph 3(H)(viii) of the Procedural Schedule, the response time for all data requests submitted on or before October 25, 2018, will be fifteen (15) calendar days, with five (5) business days to object or notify the requesting party that more than fifteen (15) calendar days will be needed to provide requested information. Thereafter, the response time will be ten (10) calendar days, with five (5) business days to object or to notify the requesting party that more than ten (10) calendar days will be needed to provide requested information. If a data request has been responded to, a party's request for a copy of the response will be timely responded to without waiting the full response time allowed.

2. This order shall be effective when issued.
