### ORDER DIRECTING UTILITIES TO RESPOND TO STAFF DATA REQUESTS

The Commission opened this file to consider best practices for recovery of past-due utility customer payments after the COVID-19 pandemic emergency and attendant economic disruptions. The Commission directed its Staff to gather information from the state's utilities about current levels of disconnections for non-payment, anticipated levels of such disconnections by those utilities in the next six months, number of customers with past-due accounts, number of customers that have received a final disconnection notice, and number of customers participating in payment plans. The Commission directed Staff to report its findings monthly until February 2022. Thereafter, on March 30, 2022, the Commission ordered Staff to file those reports quarterly, with the first report due no later than July 31, 2022.

Throughout this process, Staff has compiled the requested information for its reports by sending data requests to the various utilities. On April 11, 2022, Staff filed a motion asking the Commission to issue an order directing the utilities to file updated responses to Staff's data requests by the 15<sup>th</sup> of every month from March 2022 through December 2022.

The Commission will issue the order requested by Staff.

#### THE COMMISSION ORDERS THAT:

1. The following Missouri utilities: Ameren Missouri - Electric; Ameren Missouri-Gas; The Empire District Electric Company; The Empire District Gas Company; Evergy Missouri Metro, Inc.; Evergy Missouri West, Inc.; Spire Missouri, Inc.; Summit Natural Gas of Missouri, Inc.; Confluence Rivers Utility Operating Company, Inc., Elm Hills Utility Operating Company, Inc., Hillcrest Utility Operating Company, Inc., Indian Hills Utility Operating Company, Inc., and Raccoon Creek Utility Operating Company, Inc.; Liberty Utilities (Missouri Water), LLC; Missouri-American Water Company; and The Raytown Water Company, shall file updated responses to Staff's data requests by the 15<sup>th</sup> day of every month from March 2022 through December 2022.

2. This order shall be effective when issued.
