**MOTION TO RESET EARLY PREHEARING CONFERENCE**


Comes now Missouri-American Water Company (MAWC or Company), and, for its Motion to Reset the Early Prehearing Conference states as follows to the Missouri Public Service Commission (Commission):

1. On April 3, 2008, the Commission issued its Suspension Order and Notice, Order Setting Hearings, Order Directing Filing, and Order Consolidating Cases. Among other things, that order set this case for an early prehearing conference on April 18, 2008, for the purpose of discussing a procedural schedule.
2. Both local counsel for MAWC are unavailable on April 18, 2008. Accordingly, MAWC moves the Commission to set a new date for the early prehearing conference.
3. MAWC would propose that the prehearing conference be reset for April 17, 2008.
4. Counsel for MAWC has discussed this matter with counsel for the Office of the Public Counsel and the Staff of the Commission. These counsel have stated that they do not object to MAWC's motion.

WHEREFORE, MAWC respectfully requests the Commission to issue its order resetting

the early prehearing conference for April 17, 2008.
